Passport and EHIC cards

As stated above, you will need to provide your child's passport details on Parent Pay before we travel. Their passport will then need to be brought into school in an envelope with their full name and tutor group written on the front and given in to the school shop by **Friday 2nd May**. Students will receive a receipt upon doing this. Alternatively, you can bring your child's passport in on our Parent Information Evening in a few weeks' time (see details above). Please ensure that your child's passport is in date and valid. Regulations for travel state that, "If you are planning to travel to an EU country, you must follow the [Schengen area passport requirements](#)."

Your passport must be:

- issued less than 10 years before the date you enter the country (check the 'date of issue')
- valid for at least 3 months after the day you plan to leave (check the 'expiry date')

You must check your passport meets these requirements before you travel. If your passport was issued before 1 October 2018, extra months may have been added to its expiry date".
